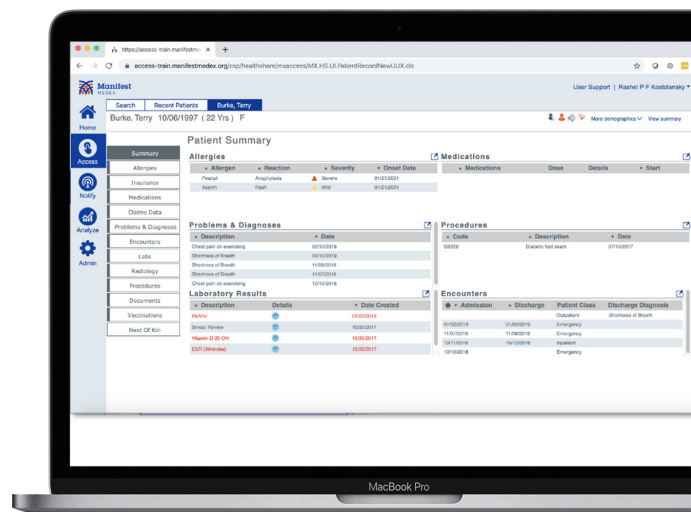

MX Access (Longitudinal Health Records)

MX Access gives you longitudinal health records for your patients, including recent encounters, a list of all your patients' providers, lab results from recent doctor visits, and up to date contact information aggregated from across the state. Information can be viewed via the MX portal or securely integrated directly into your organization's electronic health records, population health management platform, or care coordination systems. Learn at a glance if a patient is eligible for Enhanced Care Management to ensure they receive the whole person care they need.



MX Notify (ADT Notifications)

When a patient checks into or is discharged from one of the more than 140 participating California hospitals, MX Notify delivers a real-time notification to providers who are "subscribed" to that patient. The care management team can contact patients post-discharge to improve care coordination and reduce readmissions. Alerts are deliverable via MX portal, secure email, or batch files.
