



Participate in TEFCA™ with Manifest MedEx

A trusted single solution to join TEFCA and meet the California Data Exchange Framework data sharing requirements

Manifest MedEx (MX) is among the first health information exchanges in the country to participate in TEFCA™, a set of policies, standards, and technical requirements designed to facilitate the secure and interoperable health information exchange across different organizations and systems in the U.S.

We help California providers, hospitals, health plans, and public health agencies also participate in the Trusted Exchange Framework and Common Agreement™ (TEFCA).

This national connectivity is enabled through our partnership with eHealth Exchange, a designated TEFCA Qualified Health Information Network (QHIN) and the oldest and largest nonprofit health information network in the country.

Participants of Manifest MedEx can now deliver their data – securely and appropriately when queried – to other TEFCA participants through our network. By sharing their data, healthcare providers across the country can access more comprehensive patient records to enhance care coordination, minimize errors and duplicative services, improve clinician decision-making, and support public health initiatives.

Through our statewide health data network, we provide organizations a trusted single solution to join both the California Data Exchange Framework and TEFCA.

How does it work?

TEFCA aims to ensure that health data can be accessed securely and seamlessly by authorized users, regardless of where the data is stored, or which electronic health record system is being used.

When a TEFCA participant queries a QHIN for an individual's health record, that QHIN distributes the query to all the other **designated QHINs**, including eHealth Exchange. eHealth Exchange then forwards patient searches for that record to all the participants in its QHIN according to the state in the individual's address.

Manifest MedEx processes patient search requests for Treatment and Individual Access queries for individuals located in California and responds with our Master Patient Index ID (MPIID), powered by best-in-class referential patient matching. TEFCA participants across all other QHINs follow a similar approach, although there may be some variation in patient matching.

The requestor can then submit a document query using the appropriate MPIID, and MX will respond with the document ID for the requested CCDA. The requestor can then send a document retrieval request using the provided document ID. The information that MX returns is limited to information from organizations that have signed up for MX's TEFCA service.

Additionally, as a participant of the national networks, MX can collaborate with you to determine the best design to meet your data needs.

Manifest MedEx as a Qualified Health Information Organization (QHIO)



Manifest MedEx (MX) helps organizations securely exchange data as required under the California Data Exchange Framework (DxF) and serves as a Qualified Health Information Organization (QHIO).

We help DxF participants **initiate**, **receive**, and **reply** to requests for health information through our statewide health data network, providing a trusted single solution to join both the California Data Exchange Framework and TEFCA™.

Our goal is to advance a health data safety net for California by making it as easy as possible for more organizations – regardless of their geography, size, and resources – to participate in the DxF and TEFCA to securely share critical health information needed to improve the health and wellness of all Californians.
